There was a break for socializing, then Allan and Tom demonstrated the use of HF equipment for operating Field Day phone, along with some good and bad operating habits.

Good habits include: using proper phonetics (not the ones Tom used: Xylophone, Ptomaine, and Tsunami), and having the ARRL US/Canada section list available on the logging computer screen. Tom recommended working DUPES as it's faster than trying to tell the other operator about the issue. With modern logging software and computerized logs there's no penalty for dupes as they will be marked appropriately.

Tom said that he has written a ADIF parser in Python so he could read and convert ADIF logs to either Cabrillo or a format suitable for dupe-checking.

The ARRL requires only a DUPE check listing of unique calls worked per band/mode, which is generated from all the club's logs after the contest.

The meeting was adjourned at 20:30 PDT.

#### October RVARC Visit by ARRL Northwestern Division Director Jim Pace, K7CEX

The ARRL Northwest Division Director, Jim Pace, K7CEX, will visit the RVARC during our October meeting on October 1st, 2015. This will be your chance to discuss amateur radio, the ARRL, and various ARRL programs, and give input directly to your ARRL representative on matters of interest. It's been 3 or 4 years since we've had this opportunity.

**Biography:** James (Jim) D. Pace, K7CEX, ARRL Northwestern Division Director was first licensed in 1957 as KN7CEX, he upgraded to General in 1958. Over nearly 56 years, Jim has been an active operator, promoting Amateur Radio and ARRL at every opportunity. He has served as an OES, DEC, SEC and ASM in Western Washington. As Section Manager, he worked hard to strengthen Amateur Radio in Western Washington, including the ARES program which has become one of the more successful in the Nation. The Western Washington OO program is the most active in the Nation, logging several hundred hours of monitoring each month and the Technical Specialist program has become a Technical Assistance program, for the benefit of all Hams - new or old.

Over the past four years Jim has worked hard to develop good relationships between Western Washington Amateur Radio Community and our served agencies, such as: Department of Natural Resources, FEMA Region 10, Washington Emergency Management Division, Washington State Patrol and State Guard, and many others including our County Emergency Managers. Jim is currently serving as the Washington State RACES Officer and represents Amateur Radio on the State Emergency Communications Committee (SECC), which oversees the EAS and AMBER alert programs. Jim has 2 children; Tammy who Lives in Pensacola Florida and Zach who lives in Beaverton, Oregon. Jim is retired but fills his time with church work, time with his children and Ham Radio.

#### Field Day 2015

We held our club's Field Day this year at the Jackson County Fire Station 3 field area, pretty close to Dodge Bridge Park.

The site is good—with an excellent HF shot towards almost all directions, but particularly good towards the East.

This year we operated 4A—four transmitters, club or non-club group. We were in fact able to keep all 4 stations going much of the weekend due to heroic efforts by Allan, Mike, Scott, and Dave, with operating assistance by a number of other club members.

This year the phone guys arrived on site first and immediately picked out the site next to the trees, leaving the CW folks the wide open and unfortunately unbearably hot unshaded field.

tennas were literally too hot to handle, and we called off the work for a few hours until the sun set and the metal could cool a bit.

On CW, we had a crank-up tower for the club tribander, and a Hazer on 30 foot tower for Mike's 205BA 20M monobander, and a 40m dipole. On Phone, we had Scott's AB577 crank up tower with a tribander and a 40m dipole.

On Saturday it became apparent that 10m would not open much if at all, and that 15m would be marginal. 20m was incredibly crowded, especially on phone, Any attempt to hold a frequency was met with other stations encroaching within seconds and within a few hundred Hertz. The only effective approach was to hang on and muscle through the intense QRM. 40m was not quite so

crowded, but still much more heavily occupied than in previous years when 10 and 15 could handle more of the load. 40m was full right up to 7.300 MHz. with no breathing room at the top of the band.

CW was a little better as the number of contestants is slightly low-

er, and the bandwidth is a lot smaller. Good tight CW filters were needed for 20m, and

each other through the intense interference. Our effort this year focused on the key bands of 20m and 40m, and long hours of operating in the 107F heat on Saturday paid

off with the best score the RVARC has ever submitted.

the CW bulletin (thanks, Bud), emergency power, and others. We did not have a GOTA station this year, which probably worked to our score advantage as we could focus all operating on the high-run-rate stations.

score for 2015 is in the table, below. Once again the Phone ops made more QSOs than the CW ops. However because the CW contacts are worth twice as many points per contact, the CW ops out-pointed the Phone operators.

Overall this was a very strong club effort, our score was just as hot as the weather. It is

likely we are going to be high in the rankings. Our score this year would have won the Oregon section last year, and come in the top ten in the Northwestern division. We'll have to see if other clubs had similar good years. The results typically appear in the December issue of QST, and may be released earlier on the web. We'll include a score summary when available from the ARRL.
